It was moved by Mr. Fries and supported by Mrs. Bush to approve the 2024-25 Non-Union Conditions of Employment. Ayes: Bush, Fries, O'Dell. Nays: None. Motion carried 3-0.

It was moved by Mr. Fries and supported by Mrs. Bush to approve the 4% increase based on 23-24 hourly/salary amount for the 24-25 school year for all non-union employees and administration, including the superintendent, noting it included the superintendent's contract. Ayes: Bush, Fries, O'Dell. Nays: None. Motion carried 3-0.

It was moved by Mr. Fries and supported by Mrs. Bush to approve the appointment of Sarah Beckle, White Pigeon Community Schools, representative to the St. Joseph Special Education Parent Advisory Committee (PAC) for a term of May 1, 2024-April 30, 2026.
